Subject: Re-Appointment of Committee Members to the Citizens' Bond Oversight Committee

The Independent Citizens' Bond Oversight Committee is a committee appointed in the past by the Washington Township Health Care District Board of Directors to oversee the disbursement of the Measure FF and Measure Z bond proceeds. The original Committee members were appointed in 2005 and its members were re-appointed in 2015. This Committee was charged with the responsibility to monitor and report to the community that Measure FF and Measure Z funds were expended appropriately during the progress of Phase II of the Facility Master Plan.

On November 3, 2020, voters approved Bond Measure XX which will enable the District to meet the needs of the community now and into the future, to fulfill the state-mandated requirement for earthquake safety, to allow the hospital to be here for the community in the event of a public health emergency or natural disaster, to ensure local access to high quality health care services, and to support Washington Hospital becoming a designated trauma center. The proceeds for this bond are being used to design and build a new seismically safe building adjacent to the Morris Hyman Critical Care Pavilion and to complete the buildout of services in the Pavilion's unfinished shell space. An Independent Citizens' Bond Oversight Committee was appointed in 2022 to oversee the disbursement of the Measure XX bond proceeds.
